The undersigned franchisee affirms and agrees that the Summary Sales Report constitutes "Confidential Information" pursuant to the franchise agreement between the Company and the undersigned franchisee and agrees that it shall abide by the provisions governing the protection of Confidential Information as set out therein and that a failure to do so shall constitute a breach of the franchise agreement.
